## 12. Correspondence-

**12.1** J. Watt received an email from a resident with concerns about the bins at the recreation ground not being emptied by Caneco, in particular, the one at the playground.

**Comments:** A. Nicholson has been in touch with Caneco and Ben Fitter-Harding regarding the matter, and they have assured her that the issue will be rectified. The parish council will continue to monitor the situation.

**12.2** It has been reported that the fence at the rear of the playground is in a state of disrepair.

## **13. Jubilee Celebrations Update**

Leaflets are ready for distribution. The village has been divided into areas for volunteers to deliver leaflets. Timings for the day have been finalised and published on website and social media.

Tombola drum will be loaned on the day from the Friends of Bekesbourne Church.

- D. Sladden has offered to be the on site first aider for the day.
- C. Ash has offered to help transport tables to the pavilion.

## 14. Defibrillator Scheme

Nicola has applied for a grant through CCC toward the cost of a defibrillator and has emailed Adisham PC to ask about their defibrillator. Will continue to look into costs.

## 15. Allotments

As previously agreed, allotment eviction notices were given to plots 4, 5 and 9. However since then correspondence has been received from plot 5 and 9 requesting to keep their plots. (Plot 5 is happy to terminate the tenancy as he no longer wishes to have the plot anyway) A lot of effort has been put into clearing the plots and they are now up to the expected standard as per the tenancy agreement.

**Action**: Councillors agreed to offer new tenancy to plots 4 and 9, and to conduct inspections more regularly for all plots.

## 16. Standing Orders- to review and approve

It was unanimously agreed to adopt the NALC Model Standing Orders.

## 17. Community Awareness & Farming

A discussion was had about raising awareness in the community about farming. C. Ash felt it was important for people to understand why things happen and when. For example, why electric fences are installed, why crops are managed the way they are etc and allow people an opportunity top ask questions.
