Working for you all all year round

This is my monthly update for April 2025.

It's certainly been a month a road works, and there doesn't seem to be much reprieve from this in the next few months. I nearly every case this is due to utility companies who have a legal right to access their infrastructure, or developers working on improvements that they legally have to deliver as part of planning consents. Although KCC issue the permits for these closures, in reality they can't refuse permits but they do need to do a better job of challenging emergency works and coordinating closures, and I continue to pass on all complaints and push for intervention.

I am pleased to see that many of the potholes that I have reported for action have been filled, and others are scheduled to be repaired.

I met up with landowners, National Highways and the Kent Police Rural Task force in the A2 Lay-by near Shelvin Lane. This has been a hotspot for crime and damage to property. National Highways are now looking into various options to address this.

I attended the KCC scrutiny committee where the decision to remove the funding to district councils to help collect council tax was challenged.

On Canterbury City Council I attended the Cabinet meeting and a meeting of the Kent & Medway Fire Authority but it has been a quieter month of meetings due to the KCC elections and the purdah restrictions placed on councils which is why I have not attended parish council meetings in April.

Other issues covered this month have including assisting council home tenants, planning issues, new bus stop request, overgrown trees, blocked drains, and mowing of wildflowers.

I was very pleased to be asked to take part in the Passions in Public Health Podcast.

Finally, KCC elections take place on 1 May. I hope to be back with another monthly report next month, but that is in the hands of the electorate!

April was a busy and productive month, during which I continued to engage with parish councils and residents across the ward.

Early in the month, I attended the **Littlebourne** Parish Council meeting, where a range of local matters were discussed. It was encouraging to see community members actively participating and raising important issues that affect their daily lives.

I also took part in the Annual Meeting of **Ickham and Well** Parish Council, which featured an insightful presentation from the Kentish Stour Countryside Partnership. Their talk highlighted important environmental work taking place in the area, particularly regarding biodiversity and river restoration. In addition, we heard comprehensive reports from all the various committees, reflecting the breadth of work being done at the local level.

Later in the month, I joined the **Adisham** Parish Council meeting. Topics discussed included the Canterbury District Local Plan, grounds maintenance, and ongoing discussions around devolution. These are all vital issues that will shape the future of our communities, and I welcomed the chance to contribute and hear the concerns of residents and councillors alike.

At **Wickhambreaux** Parish Council, several key concerns were raised, particularly around parking, food and garden waste collections, and further updates on the devolution process. I am continuing to follow up on these matters and liaise with officers where necessary to ensure progress is made.

Throughout April, I have been actively involved in a variety of casework. This has included a frustrating water leak in **Wickhambreaux**, a planning case in **Stodmarsh**, and supporting a resident in **Bekesbourne** with a complex housing application. I have also continued to press for resolution of several waste and bin collection issues across the ward, ensuring that residents' concerns are heard and addressed.

Behind the scenes, I have been chasing up enforcement cases in Littlebourne, Wickhambreaux, and Stodmarsh, working closely with council officers to encourage timely and effective responses. These efforts often go unseen, but they are crucial to maintaining standards and protecting our communities.

On a political note, I was delighted to see my friend and colleague **Mike Sole** re-elected as our **Kent County Councillor for Canterbury South**. His significant win reflects the trust residents place in his work and offers him a renewed mandate to serve during what promises to be a complex and challenging period for the county. I'm also proud to report that our colleague in Canterbury North was also elected, contributing to the Liberal Democrats becoming the official opposition on the County Council.

Looking ahead, a significant moment approaches on 13th May, when the City Council Planning Committee will consider the controversial Gladman development proposal for over 300 homes on The Hill in **Littlebourne.** As a planning committee member who has been openly opposed to the proposal, I will speak at the meeting but will not be able to vote. The Parish Chair, the local action group, and many residents will also speak in opposition. I encourage everyone concerned to attend and show the strength of community resistance to this overdevelopment, which threatens the rural character of our village.
